CITY OF LAGRANGE, GEORGIA REGULAR MEETING OF THE MAYOR AND COUNCIL

June 9, 2020

IN ORDER TO MAINTAIN SOCIAL DISTANCING, THE MAYOR AND COUNCIL HELD THEIR MEETING AT DEL AVANT, 141 MAIN STREET, LAGRANGE, GEORGIA.

Present: Mayor Jim Thornton; Council Members Nathan Gaskin, Mark Mitchell, Tom Gore, Willie Edmondson, Jim Arrington, and LeGree McCamey

Also Present: City Manager Meg Kelsey; City Clerk Sue Olson; Assistant City Manager Bill Bulloch; City Attorney Jeff Todd; Communications Manager Katie Van Schoor; Community Development Director Alton West

The meeting was called to order by Mayor Thornton, the invocation was given by Rev. Ann Baker, Word of Grace Christian Center, and Mayor Thornton led the Pledge of Allegiance to the Flag.

On a motion by Mr. Edmondson seconded by Mr. Gaskin, Council unanimously approved the minutes of the regular Council meeting held on May 26, 2020.

A public hearing was held to receive comments on the 2020-2021 Budget. No comments were received and Council heard the first reading of the following ordinance:

TO PROVIDE FOR THE ADOPTION OF A BUDGET CONTAINING ESTIMATES OF PROPOSED REVENUES AND EXPENDITURES FOR THE CITY OF LAGRANGE FOR THE 12-MONTH PERIOD BEGINNING JULY 1, 2020 AND ENDING JUNE 30, 2021; TO PROVIDE FOR SEPARABILITY; TO FIX AN EFFECTIVE DATE; TO REPEAL CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

Mr. West presented to the Council a Board of Planning and Zoning Appeals recommendation on a request to rezone 610 Greenville Street from G-I (General Industrial) to C-3 (General Commercial). On a motion by Mr. McCamey seconded by Mr. Edmondson, Council voted unanimously to call for a public hearing on July 14, 2020 at 5:30 p.m.

Mr. West presented to the Council a Board of Planning and Zoning Appeals recommendation on a request to rezone 105 Cooley Road from C-1 (Neighborhood Commercial) to R-2 (Residential). On a motion by Mr. McCamey seconded by Mr. Arrington, Council voted unanimously to call for a public hearing on July 14, 2020 at 5:30 p.m.

Mr. West presented to the Council a Board of Planning and Zoning Appeals recommendation on a request to rezone 407 N. Greenwood Street from O-I-R (Office-Institutional-Residential) to C-1 (Neighborhood Commercial). On a motion by Mr. Gaskin seconded by Mr. Arrington, Council voted unanimously to call for a public hearing on July 14, 2020 at 5:30 p.m.

Mr. West presented to the Council a Board of Planning and Zoning Appeals recommendation on a text amendment to modify the size of allowed eating establishments within the C-1 District. On a motion by Mr. Edmondson seconded by Mr. Gaskin, Council voted unanimously to call for a public hearing on July 14, 2020 at 5:30 p.m.

Mr. West presented to the Council a Board of Planning and Zoning Appeals recommendation on a text amendment to amend the sign ordinance within the C-1 District. On a motion by Mr. Mitchell seconded by Mr. Gaskin, Council voted unanimously to call for a public hearing on July 14, 2020 at 5:30 p.m.

Mr. Edmondson thanked Mayor Thornton for the open discussions held in the Work Session on this date, June 9, 2020, at 11:00 a.m. Mr. Gaskin thanked Mayor Thornton also.

Ms. Kelsey presented copies of the May financial statements and payment of bills over \$2,000 for Council's information.

Ms. Kelsey updated the Council on information regarding an annexation/rezoning request for Cameron Mill Road. Council had previously called for a public hearing but it was advertised for 208 Ridley Avenue rather than 141 Main Street. Therefore, the ad would need to be run again with the correct location. On a motion by Mr. Gaskin seconded by Mr. McCamey, Council voted unanimously to call for a public hearing on July 14, 2020.

Mayor Thornton discussed with the Council the need to decide where the July 14, 2020 meeting would be held, due to COVID-19 concerns that still remain. On a motion by Mr. McCamey seconded by Mr. Gore, Council voted unanimously to hold the July 14, 2020 meeting at Del Avant, 141 Main Street, LaGrange, Georgia.

On a motion by Mr. Mitchell seconded by Mr. McCamey, Council voted unanimously to declare the following items as surplus:

On a motion by Mr. Edmondson seconded by Mr. McCamey Council voted unanimously to reappoint Matt Orr and Ellis Spence to four year terms on the Board of Planning and Zoning Appeals.

On a motion by Mr. Mitchell seconded by Mr. Arrington Council voted unanimously to reappoint Joan Woodson to a one year term on the Troup Family Connection Board.

On a motion by Mr. Edmondson seconded by Mr. McCamey Council voted unanimously to reappoint Charles Milligan to a five year term on the Troup County Airport Advisory Board.

On a motion by Mr. Edmondson seconded by Mr. McCamey Council voted unanimously to appoint Scott Malone to a five year term to the Troup County Airport Advisory Board to succeed Meg Kelsey.

In closing comments, Mayor Thornton congratulated Charlie Joseph's Restaurant on their $100^{\rm th}$ anniversary in LaGrange, and thanked them for their many years of serving delicious hot dogs and hamburgers.
