# CITY OF LAGRANGE, GEORGIA REGULAR MEETING OF THE MAYOR AND COUNCIL

October 27, 2020

# IN ORDER TO MAINTAIN SOCIAL DISTANCING REQUIREMENTS, THE COUNCIL MEETING WAS HELD AT DEL AVANT, 141 MAIN STREET, LAGRANGE, GA.

Present: Mayor Jim Thornton; Council Members Nathan Gaskin, Mark Mitchell, Tom Gore, Jim Arrington, Willie Edmondson, and LeGree McCamey

Also Present: City Manager Meg Kelsey; City Clerk Sue Olson; Assistant City Manager Bill Bulloch; Communications Manager Katie Van Schoor; City Attorney Jeff Todd

The meeting was called to order by Mayor Thornton, the invocation was given by Rev. L. W. Booker of St. James Baptist Church, and Mayor Thornton led the Pledge of Allegiance to the Flag.

On a motion by Mr. McCamey seconded by Mr. Arrington, Council unanimously approved the minutes of the regular Council meeting held on October 13, 2020.

A public hearing was held to receive comments on the installment sale finance contract for 206 Ridley Avenue, LaGrange, Georgia. No comments were received.

Ms. Kelsey reminded the Council about the discussion during the work session earlier today, regarding moving Council meetings back to the regular meeting locations (City Hall 3<sup>rd</sup> floor conference room and the Council Chambers) for Work Sessions and Council meetings. Since March, when the COVID-19 pandemic began, the Council has not met in their regular meeting places, due to health and safety concerns. They are currently meeting at Del Avant, 141 Main Street, in order to maintain social distancing. On a motion by Mr. Mitchell seconded by Mr. Gaskin, Council voted unanimously to move the Work Sessions back to the City Hall 3<sup>rd</sup> floor conference room on November 10, 2020 and Council meetings back to the Council Chambers on November 24, 2020.

On a motion by Mr. Mitchell seconded by Mr. Edmondson, Council voted unanimously to authorize the Mayor and Clerk to execute a Resolution for reimbursement of 206 Ridley Avenue renovation expenses from tax exempt financing. It will be financed through the GMA Lease Poole by Center State Bank. A copy of the Resolution is on file in the City Manager's office.

On a motion by Mr. Edmondson seconded by Mr. Arrington, Council voted unanimously to authorize the Mayor and Clerk to execute certain documents relating to the renovation of 206 Ridley Avenue. A copy of the documents is on file in the City Manager's office.

### **SECTION 1**:

That the zoning map and ordinances of the City of LaGrange be amended so as to reclassify from use zone G-I (general industrial district) to R-2 (residential district) the following described real estate, to wit:

All that tract or parcel of land lying and being in Land Lot 147 of the 6<sup>th</sup> Land District, adjacent to Hunnicutt Avenue, containing 0.444 acres, more or less, and shown as Tract 1 and Tract 2 on that plat of survey entitled "Pacolet Milliken, LLC" dated August 5, 2020, prepared by Stothard Surveying, Inc., Gregory Scott Hajek, Georgia Registered Land Surveyor Number 3214, which plat is attached hereto and incorporated herein for the purposes of a more complete description.
